PMCS GRADING TERMS & STANDARDS

By signing the front side of this form, Customer acknowledges that they have read the PMCS Grading Terms and Conditions (the "Agreement") set forth below and agrees to abide by this Agreement, and further agrees that PMCS is entitled to rely upon and benefit from this Agreement.

- Paper Money Certification Services (PMCS) refers the catalog number from Standard Catalog of India & World Paper Money.
 - PMCS Grading will endeavor to provide its services within the promised time frame.
 - PMCS Grading will not certify banknotes that appear to be significantly altered or are of questionable authenticity. If PMCS rejects any banknote for grading which is against the terms and standards of the company, customer shall not be refunded with the fee paid. In order to avoid such hassles customer is requested to read all the related terms and conditions carefully before submitting the banknotes.
 - Grading involves individual judgments that are subjective and require the exercise of professional knowledge, which can change from time to time. Therefore, PMCS shall have no liability whatsoever to Customer for the grade assigned any banknote, except pursuant to PMCS Guarantee re submission as set forth on PMCS website at WWW.PMCSNOTES.COM which by signing this agreement the Customer acknowledges he has read and accepts the terms and conditions of the PMCS Grading system.
 - PMCS promises to handle the banknotes with reasonable care and responsibility. However if any of the note is damaged or lost while in possession of the company, customer will be compensated based upon the 'Declared Value' which will also be considered as an 'insurance' provided by the company as per the norms and standards. IN NO EVENT, SHALL THE TOTAL LIABILITY EXCEED THE DECLARED VALUE OF THE BANKNOTE.
 - Customer must inspect all banknotes immediately upon receiving the acknowledgement receipt and report to PMCS if any damage/discrepancies are found within 5 days of receiving the acknowledgement. If customer feels that the banknote is incorrectly described then the notes can be resubmitted for the grading upon request with the agreement of indemnifying PMCS.
 - Customer agrees (a) to pay to PMCS Grading all fees and other charges while submitting the notes (b) That all fees are exclusive of local taxes.
 - PMCS Grading shall have no liability whatsoever to Customer, or any third party for whom Customer may be acting, for any damage to any banknote, or otherwise, that the Customer is unable to signify any act or omission to act by PMCS while the banknote was in its possession, except for any damage to banknote resulting from the EFFORTLESS opening of the note folder provided by the company.
 - All terms and conditions are subject to change. Turnaround time does not include mailing time and reflect business days.
 - If there are any inconsistencies between this agreement and the English language version of the same, then the English language version shall prevail.
 - In the ordinary course of its grading operations, PMCS (I) compiles data regarding each banknote submitted for grading, but not limited to, data relating to the identity, printing, condition and grade of the banknote and (ii) may take, or have taken, one or more digital or other types of photographs, images or reproductions of each such banknote (collectively, the "Images"). In consideration for the grading services being provided by PMCS, Customer, on behalf of himself and any third party for whom Customer may be acting, hereby authorizes PMCS (I) to compile and maintain such Data with respect to each banknote submitted here under for grading; and (ii) to take, or cause to be taken, one or more Images of each such banknote, and further agrees that PMCS will be the owner of such Data and all such Images and that PMCS may use such Data and Images for reference purposes only as PMCS in its sole discretion deems appropriate, including, but not limited to, the publication and republication or reproduction in or on any media, of such Data and Images.
